You must successfully pass the written exam in order to receive certification

**ASBESTOS = 70% OR BETTER**

**HAZARDOUS WASTE = 80% OR BETTER**

*If your current certificate is from another training provider, a copy of it must be provided to the ILCJATP Office in Mt. Sterling PRIOR to registering for a refresher course. Without it, you cannot be certified*

**EACH COURSE HAS A LIMITED AMOUNT OF PARTICIPANTS**

## **ADDITIONAL INFORMATION FOR ASBESTOS LICENSEES**

You will be required to provide your License Number as provided on your IDPH-Issued Identification Card.

IDPH will forward ALL current licensees a RENEWAL APPLICATION.

ILCJATP **WILL NOT** accept this application or associated fees.

They must be returned to IDPH with all required documentation.

You must attend a refresher course of your discipline:

Worker Certificates must attend a Worker Refresher

Supervisor Certificates must attend a Supervisor Refresher
